NOTICE FOR EX-STUDENTS

All ex-students are required to fill up the online examination form by **24.03.2024**. After filling up the online Examination form, the ex-students are required to send a mail to **"exstudentlc1examform2020@gmail.com"** enclosing the following documents:

Document 1: Scanned copy of Annexure-I. The candidate must take a printout of the Annexure-I and fill in the requisite details in his/ her own handwriting (Typed forms will be rejected).

Document 2: Scanned copy of online Examination form (The students are required to take a printout of their examination form (which they have filled up at the online exam portal with signature and date on it). They are also required to paste their self-attested passport size photograph in the column provided in the exam form).

Document 3: Scanned copy of Marksheets of the relevant term:

- a) If the student is of 6th Term then he/ she is to enclose marksheets of all 2nd, 4th and 6th Term.
- b) If the student is of 4th Term then he/ she is to enclose marksheets of both 2nd and 4th Term.
- c) If the student is of 2nd Term then he/ she is to enclose marksheets of 1st & 2nd Term

Document 4: Scanned copy of the Fee receipt (For fee details see the Annexure-I) Last date

for submission of the aforesaid documents is **24th March, 2024, 5.00 p.m.**


All the aforesaid documents are to be **combined in a 'single PDF' (Legible Copy)** and send as enclosure with the mail to **"exstudentlc1examform2020@gmail.com"**.

The student must send the mail from his/ her registered institutional email ID only mentioning his/her mobile number (and also alternate number) enclosing the abovementioned documents at the earliest but not later than **24.03.2024 5.00 p.m.**
