Guidelines for Election of Three Student Members - (ICC)

The guidelines to elect three student members of the beautiline Complaints.
Committee (ICC) in terms of Section 4 (1) (2) of the University Crawle Commission (Prevention, Prohibition and Redressal of sexual hierasterists of warrant employees and students or higher educational institutions) Registations, 2015.

1. Procedure for Election:

in view of large number of students, election of 3 students representatives to the ECC with at breat one male student and one female student shall be hold in two tens. The 1st last election shall be reid at the Departmental/Centre level and the 2nd last election shall be reid at the University level.

2. Schedule of the Election:

The 1th ter election should be conducted within 2 days from the date of nonthicellon and the 2th fier election should be conducted within 2 working days. The Proclar shall be the Chief Election Officer for the election and may appoint adultional election officers as per requirement.

Day 1 - 2	1 st tier election of Class Representatives (CRs) at the Dopartment/Centre level.				
Day 3	Submission of the list of elected students (CRs) of the 1 st lier by HoD to the office of the Proctor.				
Diry 4	Filing of nomination for the 2 rd tier election.				
Day 5	Withdrawai of the nomination(s) by 5 p.m. and declaration of the list of eligible candidates for the 2 rd tier election.				
Day 6	Preparations for 2 ^{ert} ser election.				
Day 7	Voting for 2 ^{ns} tier election, counting of votes and declaration of result.				

3. 1st Tier Election:

The 1" fier election shall be held at the level of the Department/Centre. The Department Centre may have students of Under-Graduate, Post-Graduate, M. Phil and Ph.D programmes. In the 1" lier, class representative (CR) may be elected for each academic programme i.e. (i) UG, (ii) PG, (iii) M.Phil & Ph.D run by each Department.

If there are more than one operconstance for a particular academic programme, one class representative may be selected from amongst the CRs of each programme. For instance, if there are 2 sections (class) in each year of three-year UG-For instance, if there are 2 sections (class) in each year of three-year UG-Frogramme. Then 3x2=6 chas representatives (CRs) may be elected first. Thereafter, these 6 CRs may then elected one amongst them as the UG-CR. Seniously, one FG-CR may be elected to represent the Mithal & Ph.D. students of the Department/Centre. The election of the respective CRs shall be held by the department after giving due notice to the students.

The election of the class representatives should be conducted by the Department/ Centre through a democratic, fair and transparent process and the Head of the Department shall ensure the same.


The Head of the Department/Centre shall forward the list of class representatives of the 15 tier election, which shall consists of 1 UG-CR representing Under-Graduate students (4 any); 1 PG-CR at the Master's / Post-Graduate level (including LLB); 1 Research CR representing M-Phil (LLM) students & Ph.D. scholars, of which at least one of the CRs should be female.

The following shall be the eligibility criteria for being elected as a C.R.:

- (iii) HerShe should be a student pursuing regular degree course in the University.
- (b) Age limit for contesting 2" her election will be:

UG 17 to 22 years PG 22 to 25 years M Philiph D 26 years

- (c) Minimum 75% attendance in the previous year / semester, as applicable;
- (d) No backlog of papers;
- (e) Must have secured at least 55% consolidated marks in the latest final assamination:
- (f) Not subjected to any disciplinary action in the past and should not have any oriminal second.

4. 2nd Tier Election:

The names of the CRs sent by the Department / Centre to the Proctor's Office shall be the exhaustive list of electionate as well as probable candidates for the 2" feer of the Proctor of the University level. The 2" feer election shall be conducted by the office separately for each level (UG/PG/M.Phil & Ph.D), wherein at least one of the cingbody cateries.

- Each nominee should have at least one semester remaining for obtaining the degree on the date of filing the nomination.
- Should not have contested 2nd the election of the ICC in the past.

The 2rd tier of election shall be subject to a maximum of 10 candidates swelting election of three posts of ICC membership. At least one female candidate each from UG, PG and Research programmes should figure in these 10 candidates for the 2rd tier election.

A maximum of five (δ) days shall be given for filing the nominations for 2^m ser election and the nominees shall be given 2 days to withdraw their nominations. The final list of candidates for the 2^m fier election may be announced within 24 hours of withdrawal of nominations. The 2^m for election shall be held within seven (7) sorting days from the data of announcement of the list of eligible candidates

The election in the 2rd tier will be on the basis of preferential voting. The candidates receiving maximum number of votes among each category i.e. U.G. P.G. and Research, shall be declared elected, provided that at least one is a female candidate. If all the three candidates who secured the highest votes in 2rd tier election turn out to be male students, then to ensure at least one female student representation in the ICC, the marks secured in class XII by those three candidates who exceeded highest votes) shall be referred to Amongst the three candidates, who ever secured the least in the Class XII boards examination shall be eliminated and in his place the woman candidate of the same category who received the highest number of votes shall be the student representative to the ICC for that category.

In case of a bie, the candidate getting higher percentage of consolidated marks in the previous examination shall be declared as elected.

The election result shall be duly notified. The three students so elected shall serve as Student Representatives in the ICC.
